

UPDATE : EDUCATIONAL ASSISTANT PA DAYS – August 2008 to June 2009

Educational Assistants are eligible for up to 4 PA Days during the 2008/2009 School Calendar.

As the school calendar for the Elementary and Secondary Panel are different, the configuration of the PA Days is different and is dependent upon the Panel you are working in.

The number of working days and number of PA Days for each Panel is the same (188 days + 4 available PA Days).

May 1, 2009 – Secondary Panel EA PA Day

– Secondary full time or part time are eligible to attend for the full day and will be paid if in attendance. (As this is a voluntary day EA’s who do not attend will not be paid – there is no access to sick leave, personal days, etc.) Further details will be forwarded in the New Year with regards to the plans/activities for this day.

- Regular working day for Elementary Panel Educational Assistants

June 26, 2009 – Elementary Panel EA PA Day

- Elementary full time or part time are eligible to attend for the full day and will be paid if in attendance. (As this is a voluntary day EA’s who do not attend will not be paid – there is no access to sick leave, personal days, etc.) Further details will be forwarded in the New Year with regards to the plans/activities for this day.
